## **Privacy Policy**

The vStream Group ("Company", "we", "us" and/or "our") is committed to protecting your personal information. We've developed this Privacy Policy to explain how we collect, use and share your personal information when you use vStream.ie and any other sites owned and operated by us (collectively, the "Sites"), our mobile applications (collectively, the "Apps"), and any other products, devices or services offered by us or through third parties integrating Company functionality (collectively with Sites and Apps, the "Services").

This page informs you of our policies regarding the collection, use, and disclosure of personal data when you use our Service and the choices you have associated with that data.

We use your data to provide and improve the Service. By using the Service, you agree to the collection and use of information in accordance with this policy.

#### Information Collection And Use

## Types of Data Collected

## **Usage Data**

We may also collect information how the Service is accessed and used ("Usage Data"). # **Tracking & Cookies Data**

We use cookies and similar tracking technologies to track the activity on our Service and hold certain information.

Cookies are files with small amount of data which may include an anonymous unique identifier. Cookies are sent to your browser from a website and stored on your device. Tracking technologies also used are beacons, tags, and scripts to collect and track information and to improve and analyse our Service.
